## **ARCHITECTURAL REVIEW COMMITTEE (ARC) REPORT**

Hello Montage Neighbors.

The Architectural Review Committee (ARC) continues to meet on a monthly basis to review Architectural Improvement Requests (AIRs) and conduct periodic landscaping, lighting and community area inspections.

We will be conducting our quarterly light inspection and semi-annual landscape/home inspection in the coming weeks.

The following is a summary of our current activities:

- Lighting Maintenance The Committee has been working with our current contractor to oversee and improve the service on association light inspections and repair. Based on our recommendations, the Board is planning to issue a request for proposals for this ongoing service.
- Perimeter Lighting The Committee will continue to work with the Board on the development of a request for proposal for new palm tree lighting.
- Landscape Maintenance The Committee took the lead, in conjunction with our landscape contractor account manager, in developing recommendations for this year's Palm Tree Plan project that were approved by the Board. This effort has resulted in the focus on completing the planned work at the entrances. You should have noticed several new date palms at both property entrances along with several new perimeter palms.

We continue to work with the Association landscape contractor to oversee, maintain and improve the Montage perimeter and common area landscape. Monthly property walks with our contractor account manager are an important factor in helping us make sure our landscape looks great and our costs are managed properly. We have recently removed many of the perimeter grasses that were at end of life and added replacement plants, including 2 agaves near the message boards.

 Mailboxes\_— The Committee will present its findings on potential mailbox replacement at the May Board Meeting. Our 20 year old mailboxes are at a point that replacement parts are difficult to obtain, our reserve study indicates that the mailboxes are at the end of their useful life. More information will be forthcoming in the months ahead regarding this project.

In addition, based on the results of our Annual Membership Meeting, we plan to help evaluate the feasibility of cameras at the gates, gate aesthetics, and additional uses of the retention basin. Hopefully, separate task forces will be setup for some of these projects; however, the ARC is prepared to help as needed.

I wanted to take this opportunity to congratulate and welcome Norm Giere our Committee Chair for the past year as a new Board member. Ideally, we will find a new Committee Chair to work with Norm on the Committee but in the meantime, he has indicated his willingness to continue serving. As a fulltime resident, Norm has done a great job of helping to oversee the property during his daily walks, developed and analyzed numerous association projects and has made a significant contribution to help keep our community in great shape.

I also want to thank our dedicated Committee members: David Busick, John Geary, Richard Meyerson, Dennis Nello and John Claeys — without whose commitment to attending our monthly meetings and being involved in our inspections, we could not complete the ongoing work described above.

"no dog owner shall knowingly fail, refuse, or neglect to clean up any feces of the dog immediately and dispose of it in a sanitary manner whenever the dog has defecated upon public or private property." In addition, our "Rules and Regulations for Montage at Mission Hills" states that "Failure to pick up after pet" will incur a \$100 fine.

So please be a good neighbor and pet parent, and follow the rules and regulations.

Don't let our dogs get a bad reputation due to our neglect.

In case of an emergency, gather ASAP at the end of Chagall Court where we will receive instructions on what to do next and how to provide for ourselves as a community.





As A Reminder... Montage garage lights MUST remain on at night. These lights are controlled by a photocell located on the side of your home. A control switch inside your home near the front door MUST be left in the ON position in order for the lights to work. Guests and cleaning crews sometimes inadvertently turn off this switch. In order to always stay in compliance we suggest the use of a clear plastic SWITCH LOCK. #### **SPEED LIMIT**

Within the community the maximum speed is 25 mph. Since we do not have sidewalks please drive safely and pay special attention to pedestrians, especially in the evening hours.

Please be respectful of your neighbors when entertaining outdoors. Loud noise, loud or unruly children, loud music or similar sounds that may emanate from a residence are not permitted between the hours of 10 pm and 7 am.
